## Horse Trail Riding Expo Participant Liability Release Waiver

The following must be signed and dated before participating.

I, \_\_\_\_\_ (print name), WISH to participate in the Horse Trail Riding Expo to be held at Chance Ridge Event Center, 508 Skyline Drive, Elkhorn, Nebraska on March 10 & 11, 2018. I understand equine activities are a high risk activity which involves dangerous situations where injury and damage can occur; due to the location medical services, communications, and transportation can be delayed; natural or man-made hazards can cause accidents not anticipated by the manager, property owners or their representatives; horse can be excitable, difficult to control and unpredictable; belongings can be damaged, lost, or stolen; and that accidents can happen to anyone at any time.

I AGREE to assume all risks associated with my participation in this activity, and I accept full responsibility for myself, my guest(s), and the animal(s) I am riding. As a condition precedent to my being allowed to participate in this activity, I agree that I will not sue or bring any claim against the Nebraska Horse Trails Committee, Inc., the Horse Trail Riding Expo's organizers, volunteers, the owners of Chance Ridge Event Center, their employees, and/or any other individual participants or individuals (hereafter referred to as 'The Released Parties) for any injury, accident, death and or loss of any kind which arises out of this event, and will indemnify and hold harmless The Released Parties from all liability for such injury, accident, death or loss, even if such injury, accident, death and/or loss arises from the alleged negligence of The Released Parties. I further acknowledge that I have read and understand the State of Nebraska's Equine Activity Liability Act Warning (if applicable).

To the extent any dispute arises out of this agreement, the parties agree to submit said dispute to binding arbitration before a neutral arbitrator mutually selected by the parties, said arbitration to be conducted in accordance with the Rules of the American Arbitration Association. All such arbitrations shall be held in Douglas County, Nebraska. If the prevailing party shall be allowed to recover all costs and expenses incurred, including attorney fees and costs.

**Participation, Stalling & Waste Removal Information**

- All Participants must be 16 years of age or older (unless otherwise specified). All horses participating in the event must be 3 years old or older unless a younger age is requested by the presenter.
- Do not bring a horse that has behavioral issues, including but not limited to, kicking, bucking or rearing or if the horse is not use to crowds or other horses.** We reserve the right to dismiss any horse from a demo if it is deemed unsafe for its owner, presenter or other riders.
- No stallions will be allowed to participate in this event. No exceptions.
- Do not bring additional horses to this event unless registered on page 1.
- Participants and their horses must be on the premises 90 minutes prior to your assigned clinic or demonstration. Check in at the WEST ARENA ENTRANCE when you arrive. If you did not purchase a stall at the event, your horse must remain in the trailer until your scheduled event. All overnight horses must be in stalls.
- Horses stalled at the event may arrive Friday evening after 4:00 PM or Saturday morning.
- Please note there are no wash facilities at this venue. Please bring a clean horse.
- Bring your own shavings and clean your own stall and around your trailer at the conclusion of this event. There will be a site for manure and used shavings. **DO NOT MAKE THE VOLUNTEERS CLEAN UP AFTER YOUR HORSE.**
- This event is an all volunteer event for fundraising for our horse trails. We appreciate your participation.

**Payment**

- All Participants in clinics and demos will be assigned on a "first-received" basis according to the postmark and provided we deem suitable for the specific clinic.
- Every attempt will be made to assign the Participant to the clinic of their choice. Please read the requirements carefully to see if you and your horse will qualify for that clinic or demo.
- All HTRE management decisions are final
